3. On Purchase/Booking on the Product package, all application will be authorized for promoting the packages of the company.
4. On Purchase/Booking Products, the registration with the company does not create any employee-employer relationship, or joint venture between the distributor and the company.
5. Any individual whose age is 18 years or above and residing in India is eligible to become independent distributor.
6. A person can not sponsor any other individual until he himself becomes a distributor and the company receives his payment for the package.
7. If any distributor is unable to sponsor any other distributor within 90 days from the date of joining then he/she can deposit the balance amount for the package booked and take their package.

12. Price at the time of delivery will be applicable.

14. If any of the packages is found damaged/ spoiled kindly report within 48 hours to Authorized Service Centre or Franchise. No claim will be considered thereafter.
